## 1. Get to know our online services terms of use

These Terms of Use outline how you can use Rockgas' websites, mobile apps, and online portals (together, our Online Services) and are between you and MM Corps (Mid Canterbury) Ltd, t/as Rockgas Mid Canterbury ('Rockgas'). By using the Online Services, you agree to follow these terms - so let's break it down...

## 2. Using our online services

---

### Acceptance of these terms

When you use our Online Services, you agree to these Online Services Terms of Use (Terms). If you don't agree to the Terms you can stop using our Online Services at any time.

These terms are effective from 1 April 2025

### Other terms might still apply

Our LPG supply, services, and promotions have their own terms and conditions. If there's ever a conflict between those terms and these ones, the service-specific terms take priority. You can find those on our [website](#).

### Keeping things up to date

We may:

- Change or update the Online Services at any time.
- Remove or suspend features without notice.
- Update these Terms when needed.

If you do not wish to accept any changes to the terms and conditions, you can stop using our online services at any time.

### Check back for updates

We recommend checking these Terms from time to time. If you keep using our Online Services after we've made changes, that means you accept the updated Terms.

## 3. General information and liability

---

### Information on our website

If you place an order or update details through our Online Services, we'll assume the instructions came from you. The way we handle this information is in our Privacy Policy, so it's worth a read.

## 5. Cookies and tracking

---

**How we use cookies**

You'll need cookies enabled to access all features. We use cookies and tracking tools (like Google Analytics) to:

- Improve your browsing experience.
- Understand how our website is used.
- Deliver better marketing through Google remarketing.

## 6. Intellectual property

### **Who owns what?**

Rockgas owns, or has a license for, all content and trademarks on our Online Services. You can use our content for personal reference only, but you can't modify, copy, or share it without our written permission.

We may restrict or block your access to and use of the app and/or website at any time if we reasonably believe that you may have breached any provision in these terms and conditions.

### **Your data & our use**

You own the data you provide to us, but by using our Online Services, you give us permission to use your data for business purposes. Any insights we generate from your data (Derivative Works) belong to us.

### **Keeping your data secure**

We'll take all reasonable steps to store your data safely.

## 7. Links to other sites

### **Third-party websites**

These Terms of Use are governed by New Zealand law, and any disputes will be handled in New Zealand courts. That means if there's ever a legal issue relating to your use of our website, it will be resolved under New Zealand law, without reference to any conflicting legal principles.
